GOV: 201-01-1 "UFS Role in Supporting Campus-Level Shared Governance"

"One role of the University Faculty Senate (UFS) is to serve and enhance campus-level faculty and staff shared governance. UFS's priority in this respect is to help campuses strengthen their shared governance cultures, systems, and processes, including dialogues across campus roles (e.g., faculty, staff, administrators, students). Sometimes this support may result in sharing resources or informal conversations, and sometimes it may result in a more formal approach."



EC: 201-04-1 "Supporting the Faculty Council of Community Colleges, Defending Shared Governance"

... **FURTHER BE IT RESOLVED that** SUNY UFS affirms the centrality of shared governance, pledges to safeguard governance participation by faculty and professional staff, and defends the right of elected faculty and professional staff to represent their colleagues free from intimidation, interference, or obstruction; and

FURTHER BE IT RESOLVED UFS condemns administrative actions that diminish governance bodies' organizational capacities, undermine foundational shared governance principles, and

stony endanger governance across the entire SUNY system ...

201-07-1 "SUNY-wide Doxxing Policy and Photography and Recording Policy"

... THEREFORE BE IT RESOLVED that SUNY UFS urges Chancellor King and the Board of Trustees (BOT) ... to develop a SUNY policy affirming the authority of instructors to prohibit the photographing or recording of their classes and other private spaces, such as faculty offices, without their written permission, except as required for approved disability accommodations and other legitimate and verified circumstances; and

FURTHER BE IT RESOLVED that SUNY UFS requests that any such SUNY Photography and Recording Policy
Protect faculty academic freedom and instructional materials;
Safeguard the privacy of students and other classroom participants;
Safeguard the privacy of faculty, professional staff, and employees;
Establish clear, uniform procedures for authorized recordings; and
Define appropriate administrative and disciplinary procedures for

- determinations of, and responses to, violations; ...
