These data reflect the calculated net price for undergraduate students paying the in-state tuition rates, following accepted methodologies. The Higher Education Opportunity Act of 2008 defines institutional net price as "the average yearly price actually charged to first-time, full-time undergraduate students receiving student aid at an institution of higher education after deducting such aid." In IPEDS, average institutional net price is generated by subtracting the average amount of federal, state/local government, or institutional grant and scholarship aid from the total cost of attendance. Total cost of attendance is the sum of published tuition and required fees (lower of in-district or in-state for public institutions), books and supplies, and the weighted average for room and board and other expenses (IPEDS Glossary).

Note that two slightly different groups are represented, following federal reporting standards. The first group for which an overall net price is calculated includes students who paid the in-state or in-district tuition rate and were awarded grant or scholarship aid from the following sources: the federal government, state/local government, or the institution; students who were awarded aid only from other sources are not included. The students in the income bands include those who were awarded any Title IV federal student aid (federal grant aid, federal work study or federal student loans).

Note: CARES Act / CRRSAA HEERF II funding is not included in Net Price Calculations
